# 20/12 What is currently on Solent Students' Union's (SoSU) agenda? report

Grace Davis and Ro Tomlin-Wills highlighted current projects and initiatives as well as challenges which included:

- i. Nominations for the Students' Union election closed two weeks ago and the election would take place on 15 March 2020;
- ii. Elections for full time and part time officers had been merged for the first time;
- iii. SoSU currently had income challenges due to declining sales and competitors;
- iv. Planning was underway for Welcome Week;
- v. Working with councillors to raise awareness of safety issues around the Park area. A letter of recommendation by the safety council had been sent regarding CCTV and other initiatives;
- vi. Local venues had pledged to sign up to SoSU's anti-spiking campaign and follow its guidelines. The project was also being handled as a live brief by psychology students;
- vii. Over 1800 students had used the Safe Solent service last year and media student had worked on a promotion campaign for it;

- viii. Wellbeing and mental health training for SoSU was underway and the Wellbees scheme, which supports lonely and isolated had been relaunched;
- ix. SoSU was part of the university forum set up to encourage input to the new strategic plan;

In discussion the following points were made:

- x. In response to the Board's question, Ro Tomlin-Wills confirmed that initiation practices are not tolerated.
- xi. The new SoSU area in the Millais building now included a shop which offered some Re:So items:
- xii. The Board commended SoSU for its excellent and extensive work and noted the report.
