- i. The Committee noted a report on the training and continuous personal development activities undertaken by Governors during 2018/19.
- ii. ACTION: Clerk to add reference to the Maritime Simulation Suite Opening and the Chairman's attendance at meetings of the Committee of University Chairs (CUC). COMPLETED.

19/15 Four yearly review of Board effectiveness Presented by: Bridget Woolven

- i. The Committee reviewed Advance HE's Framework for Supporting Governing Body Effectiveness in HE and specifically the longform and shortform survey options that were available.
- ii. Members felt that the shortform survey should be supplemented by some of the questions in the longform version as well as including a new question to measure Governors' confidence in their knowledge of their obligations to the Office for Students (OfS). ACTION: Members would inform the Clerk of their suggestions for questions that should be used from the longform survey so that the Clerk can add these to the Board paper for 17 July.
- iii. The Clerk informed the Committee that AdvanceHE had confirmed that formulation of the survey and benchmark analysis of the results would be at zero cost as this service was included in Solent's membership of AdvanceHE. A link to the survey would be provided by email and submissions were confidential. Although AdvanceHE's benchmark data currently only included around 18 HEIs, at least a dozen of these were purported to be post-92 HEIs and therefore appropriate comparators for Solent.
- iv. AdvanceHE had advised the Clerk that the revised HE Code of HE Governance was likely to be published at the end of 2019.

- v. The Committee agreed to recommend to the Board on 17 July:
 - a) Use of an adapted form of AdvanceHE's shortform survey as outlined in ii;
 - b) That the survey should also be issued to VCG members to obtain their view of Board performance:
 - c) That AdvanceHE carry out an benchmark analysis of the survey results;
 - d) That the previously agreed activity to review the Board's compliance with the CUC Code of HE Governance should be delayed until after publication of the revised version.
